

**VICTIM'S STATEMENT SEEKING RESPONSE AND REDRESS
EXCLUSIVELY UNDER CIVIL RIGHTS LAWS**

I HEREBY SEEK RESPONSE AND REDRESS UNDER TITLE IV OF THE CIVIL RIGHTS ACT (applicable to public schools) AND/OR TITLE IX OF THE HIGHER EDUCATION ACT (applicable to public and private recipients of federal funds).

IF I HAVE PREVIOUSLY CONSENTED OR AGREED TO REDRESS UNDER ANY OTHER POLICY OR PROCEDURE, THAT CONSENT OR AGREEMENT IS HEREBY REVOKED.

STARTING TODAY AND CONTINUING THROUGHOUT THE PROCESS, UP TO AND INCLUDING ALL APPEALS AND FINAL DETERMINATIONS, I EXPRESSLY SEEK RESPONSE AND REDRESS ONLY UNDER THE SUBSTANTIVE AND PROCEDURAL REQUIREMENTS OF TITLE IV AND/OR TITLE IX, INCLUDING BUT NOT LIMITED TO FULLY "EQUITABLE" TREATMENT CONSISTENT WITH AND UNDER EXACTLY THE SAME SUBSTANTIVE AND PROCEDURAL REQUIREMENTS AS ARE APPLICABLE TO THE REDRESS OF MATTERS COVERED BY TITLE IV AND TITLE VI OF THE CIVIL RIGHTS ACT.

UNDER NO CIRCUMSTANCES DO I SUBMIT TO OR ACCEPT RESPONSE AND REDRESS UNDER THE FEDERAL CAMPUS SAVE ACT, THE FEDERAL VIOLENCE AGAINST WOMEN ACT, OR ANY STATE LAW OR SCHOOL-BASED POLICY OR PROCEDURE. I CHOOSE RESPONSE AND REDRESS SOLELY UNDER TITLE IX AND/OR TITLE IV BECAUSE I SUFFERED "SEVERE OR PERVASIVE" HARM, ON THE BASIS OF SEX, AND IT HAS INTERFERED WITH MY ACCESS TO EDUCATIONAL PROGRAMS OR ACTIVITIES. I UNDERSTAND THAT RESPONSE AND REDRESS EXCLUSIVELY UNDER TITLE IX AND/OR TITLE IV ENSURES THAT RELEVANT OVERSIGHT AGENCIES, SUCH AS THE OFFICE FOR CIVIL RIGHTS AT THE DEPARTMENT OF EDUCATION, WILL HAVE JURISDICTION AND AUTHORITY TO PROVIDE RECOURSE IN THE EVENT OF NONCOMPLIANCE, WHICH IS NOT POSSIBLE IF REDRESS OCCURS UNDER ANY OTHER LAW OR POLICY.
